

Bike Europe along the Danube River

Celebrate Oktoberfest in Munich

September 18 – 26, 2016

We start our trip flying into **Munich** and travel to Passau Germany to board the **MS Story**, a beautiful 175 passenger comfort-plus river boat. We will travel the picturesque Danube River, each day departing the boat to bike the countryside and charming villages, taking in castles, wineries and local life. **Biking will be easy** and mostly flat terrain. Average daily distances approx. 16-30 miles, 3 or 4 hours of pedaling so lots of time to explore! Bicycles are included in the package; electric bikes are available. **All meals are included** on the boat, and a packed lunch is provided for bicyclers. We'll travel four spectacular countries: **Germany, Slovakia, Austria and Hungary.**

On the final day we will travel back to Munich and spend the night there celebrating Oktoberfest in a beer garden!

Day 7: Wachau / Krems - Melk, 22 mi.
Day 8: Depart boat in Passau -motorcoach to Munich
Day 8: Oktoberfest - afternoon & evening
Day 9: Depart Munich to PHX
